All of the above rates are non-commissionable, and are subject to a 19.5% hotel added charge; The rate plus the added charge are subject to Michigan State Sales Tax (currently 6%) and Mackinac Island Assessment (currently 2%). Grand Hotel operates on a "NO TIPPING" policy within Grand Hotel.

There is a one-time charge for round trip luggage transfer between the boat docks and Grand Hotel on day of arrival and return on day of departure. This luggage handling charge is currently \$8.50 per person and is not a daily rate, therefore it is in addition to the rates listed above.

**DEPOSITS:** Grand Hotel requires the following deposits and rooming list for each group tour room block of up to 30 rooms:  
\$200.00 – payable at the time of confirmation. Rooms will not be held until Grand Hotel receives deposit and signed confirmation.  
\$1,000.00 – second deposit is required sixty (60) days prior to your scheduled arrival.  
\$2,000.00 – third deposit and preliminary rooming list are required thirty (30) days prior to your group’s date of arrival.

If deposits and rooming lists are not received when required, Grand Hotel reserves the right to release all accommodations and services held. All deposits once received are non-refundable and non-transferable. Once your room list is received, rooms not used will be released back to Grand Hotel inventory. Individual room cancellations must be received no later than ten (10) days prior to arrival or there will be a charge for cancellations made after this date. Room additions are based on availability.

Transportation to and from Grand Hotel is not included in the room and meal rates above. Grand Hotel’s Director of Group Tours will assist tour planners seeking to book ferry service, horse-drawn taxi transfers and horse-drawn carriage tour. Transportation rates and these island services cannot be guaranteed by Grand Hotel because we do not own or operate them.
